John Marshall Student-Athlete & Team Contract

I. Academic Excellence

Being a "Student-Athlete" places the word student first. To remain in good standing and eligible for competition:

- **GPA Requirement: All student-athletes must attain a minimum accumulative 2.0 GPA by the end of the 2027 school year.**
- **Starting Status: To be eligible for a starting position on the varsity or junior varsity roster, a student must hold a term 2.0 GPA or better.**
- Scholarship: We expect our athletes to be "Best Scholars." This means consistent attendance, active participation in class, and timely submission of all assignments.
- **Student athletes who desire to play in college MUST have a accumulative GPA at or above 2.8. Colleges start with how many student-athletes are above 2.8, when the answer is none they end the conversation.**

II. Digital Presence & Program Branding

We are proud to transition our program into the digital age.

- Website: We will utilize lawyerfootball.com as the official hub for our team.
- Showcase: This platform will be used to showcase team achievements, individual highlights, and our commitment to the community.
- Conduct: Students must represent the "Lawyer" brand with dignity. Any personal social media content that reflects poorly on the school or team may result in disciplinary action.

III. Conduct & Conflict Resolution

Character is defined by how we handle ourselves under pressure.

- **Zero Tolerance for Altercations: If a student-athlete engages in a physical or verbal altercation during any scheduled football activity—including practices, film sessions, weight room training, bus rides, or games—they will face immediate consequences.**

- Scope of Activity: This policy includes the time from which a student reports to the locker room until they are dismissed and leave school grounds.

- **EVERY student caught consuming drug in any manner on campus WILL face consequences outlined by but not limited to the Disciplinary Actions listed below:**

- Students are no longer permitted to leave the campus before the practices and games to get food. If you leave the campus, it will be marked as an unexcused absence. If you have an appointment that your parents have communicated with me and can provide appropriate documentation for, the absence or tardiness will be excused.

- Disciplinary Action: Participation in an altercation may result in:

1. Immediate suspension from the next scheduled contest.
2. A mandatory review board meeting with coaches and administration.
3. Potential removal from the athletic program.

IV. Participation and Commitment

- Attendance: Athletes are expected to be present and on time for all team events.
- Equipment: Athletes are responsible for the care and return of all issued John Marshall equipment.
